REGULATIONS

For Participation in HPR Field Trials

Participation in HPR Field Trials hosted or sanctioned by the Club is subject to the following Indemnity and Regulations. By entering and attending an HPR Field Trial, you acknowledge that you have read, understood, and agreed to abide by these terms.

1. GENERAL RULES

- All participants must comply with the rules and regulations of the KwaZulu-Natal HPR Club and the National Field Trial Association.
- Handlers are responsible for their own dogs at all times and must ensure that their dogs are under control and not a danger to people, other animals, or property.
- The Field Steward and Judges' decisions are final and must be respected.
- The Club reserves the right to refuse entry to any participant without providing reasons.
- All participants must have a valid Mpumalanga Hunting Licence. Participants must also sign an indemnity and obtain permission to hunt from the landowner. The indemnity form and permission to hunt will be completed during the registration process.

2. CONDUCT & SAFETY

- The Venue was made available through the Farm Owners' kind allowance. Please drive carefully and stay on the designated roads. Respect all people, employees, animals, and equipment on the farm. Any gates you open must be closed after you have driven through.
- The Venue needs to be left as we have found it. Please pick up all the litter.
- All participants, including owners, handlers, spectators, and officials, must conduct themselves in a respectful and sportsmanlike manner at all times.
- Entry onto the Event premises, buildings, and amenities is solely at your own risk. The entry of dogs into the Event is also entirely at your own risk.
- As winter takes hold and the grass becomes drier, smoking on the premises is strictly forbidden unless authorised by the Field Stewart.
- All dogs and puppies should be suitably vaccinated and appropriately treated for internal and external parasites.

3. PROTECTION OF PERSONAL INFORMATION

- We respect your privacy and protect the information prescribed by the Protection of Personal Information Act No. 4 of 2013 (POPIA).
- We will not share or sell your personal data or information with unaffiliated third parties or their services.
- Photographs may be taken and published by the Club on its social media platforms and website.\
- By attending the Event, you consent to the use of photographs where you or your dog may appear unless you notify the event organiser in writing before the start of the Event.
